Officers were dispatched to the above location for a report of women yelling and arguing. Three officers checked the area and did not find anyone in distress. The officers resumed patrol.

An officer was dispatched to a car rental company to take a report regarding a returned vehicle that had a bullet hole in the trunk. Upon arrival, the officer met with the on duty manager who said that the vehicle in question was rented at another location in Sugarland, Texas, on 02/15/2013. The manager said the renter returned the vehicle to his location and upon inspection it was determined that there was a bullet hole in the trunk. The officer checked the vehicle and observed a round opening on the vertical face of the rear trunk lid that would be consistent with a bullet hole. When the officer opened the trunk, he could see where the bullet traveled into the back of the rear seat and there was an exit out of the front of the seat. The officer was unable to locate any other bullet strikes or the round itself. The manager said he was not concerned with the damage to the vehicle; however, he wanted the possible gunshot documented.

A resident awoke to unusual noises in his house. The resident went to investigate and saw an unknown male in his house. The male ran out of the house and to his SUV where he fled the scene. The wife called 911 since they were unsure if there was another intruder in the house. Officers were dispatched to the location and upon arrival they checked the house and found it to be clear. While officers were at the location, another call came in for a suspicious vehicle. One officer left the location to answer the call and HPPD assisted. HPPD spotted the vehicle on Wolf Creek which is just outside of HCV. HPPD initiated a traffic stop on the suspect vehicle. One of the occupants matched the description of the male that had committed the home burglary. The occupants were detained until a HCV officer arrived. A shotgun was seen in the vehicle and property in the vehicle was consistent with the items stolen from the home. The two male occupants were detained and drugs were found in their possession. It was later confirmed that the property in the vehicle had in fact been stolen from the residence on Village Circle and the shotgun had been reported stolen through SAPD a few days earlier. A vehicle burglary had been committed at this residence and also at a different address on Village Circle. Both males were booked for their crimes.

An officer was dispatched to a pawn shop for a theft report. The officer contacted the manager who reported a male came into the store and took a projector without consent. The manager said he did not realize the male had stolen the projector until later that same day when he noticed other items were missing. The manager reviewed the video from the stores surveillance system which clearly shows the male taking the projector and walking out of the store with it. The video also shows the male making numerous trips in and out of the store, taking an item each time. At one point in the video it shows the male taking a laptop and concealing it in the front of his pants and then leaving the store. The manager provided the officer with a copy of the video.
