Offense: Recovered Stolen Property

On 05-18-2013, HCVPD patrol officers responding to a suspicious vehicle complaint apprehended two subjects arising from their initial field investigations of Burglary of a Habitation, Burglary of a Vehicle, Theft of a Firearm, and narcotic possession which had just occurred.
