Calls of Interest

Offense: Recovered Stolen Vehicle

Date: 06.06.16

Time: 0834 hours

Location: 13400 blk San Pedro

An officer had completed a traffic stop near the above listed location. Upon completion of the stop, the officer drove through the parking lot of the Office Depot located in the 13400 block of San Pedro. While doing so, the officer got a hit on the license plate reader. The plate was entered on the hot list as a stolen vehicle. The vehicle was backed into a parking spot closest to the access road and slightly south of the Pollo Tropical restaurant. The officer turned around and checked out with the car. The car was unoccupied and the officer did not observe anyone in the area of the car. The hood of the car was warm to the touch leading the officer to believe it had recently been parked in that spot. The officer conducted a computer check on the license plate which returned a stolen vehicle hit issued by the Abilene Police Department. The officer had the dispatcher verify the vehicle was stolen by contacting the Abilene Police Department. Dispatch was able to verify the stolen car hit. The officer had the vehicle impounded.

Offense: Wanted Person

Date: 06.07.16

Time: 0650 hours

Location: 13800 blk San Pedro

An officer observed a vehicle displaying a registration sticker that expired in 02/2016. The officer pulled behind the car and verified the expired registration by running the plate on the

vehicle. Upon confirmation, the officer stopped the vehicle in the Target parking lot. The officer approached the driver of the vehicle and asked for his license. He provided the officer with a Texas ID. A computer check showed the driver to have an active warrant. The driver also had active suspensions on his license. Due to the status of his license, he was placed under arrest. The vehicle was impounded and the driver was taken to jail.

Offense: Assault

Date: 06.10.16

Time: 0156 hours

Location: 15700 blk San Pedro

Officers were dispatched to a local restaurant for a possible fight. Officers arrived and contacted a female who was standing outside and to the rear of the vehicle and crying. Officers heard a male yell the words "chill out" which were being directed toward the female. The officers approached the male and observed obvious signs of intoxication and noticed a strong odor of alcoholic beverages emanating from his person. An officer instructed the male to exit the vehicle so that they could talk to which he responded "I'd rather talk right here". The officer instructed the male multiple times to exit the vehicle and he continued to refuse to do so. Due to the fact that the male was, at that time, detained and intoxicated, officers were required to use reasonable force to extract the male from the driver seat of the vehicle. During his extraction the male stated multiple times, in a yelling manner that he was not resisting, though he stiffened his entire body as well as continuously pulled his arms away from the officers and jammed his legs between the seat and steering wheel of the vehicle. Once in custody a computer check of the male's information was conducted and no warrants were found. After securing the male, officers spoke with the female. The female reported that she and the male had been out drinking to celebrate the male's birthday and the two decided to get food at the restaurant. While in the drive through line, the male began touching the female between the legs as well as grabbing her in the same area. She told the male to stop touching her and he continued to do so and at that point, the female slapped the male's arm. He became very angry and struck her back making contact with her right upper arm, causing a red mark approximately 4 inches in length. The female exited the vehicle and called a friend to pick her up from the location. Once she ended her phone call, the female re-entered the vehicle to move it out of the way of the drive through line. At that point, the male grabbed her arm with enough force to cause the female to believe that her arm was going to break. Given the information provided, the male was placed under arrest for assault. The female provided a written statement and the male was booked into jail.

Offense: Evading Arrest

Date: 06.10.16

Time: 1300 hours

Location: 500 blk West Bitters Road

An officer was running stationary traffic enforcement in the 500 block of West Bitters Road. The officer observed a red in color vehicle traveling eastbound toward his location at what appeared to be a high rate of speed. The officer was able to lock onto the vehicle which was traveling at 72 MPH. The clearly posted speed limit in that area is 40 MPH. The officer could clearly see the driver as he passed. The vehicle was a red in color Dodge Charger. The officer

activated his emergency lights and did a U-turn to begin to catch up to the vehicle. The officer could clearly see the vehicle in front of him as he was traveling in the left lane of traffic. The driver abruptly changed lanes and cut off a vehicle, then made what appeared to me to be a high speed turn off of West Bitters and onto Walker Ranch. As the officer turned onto Walker Ranch he no longer had a visual on the car. The officer approached the first intersection of Walker Ranch and Stonewood Street and observed a male standing next to a white pick-up who was pointing down the street indicating that the vehicle had come through the location. The officer traveled to the intersection of Stonewood Street and Wood Valley and did not see the red car. The officer turned around and observed several people standing in the driveway of a residence on Stonewood Street. The officer rolled down his window and asked them if they had seen a red car come down the street and they said they had not. At that time the officer traveled back toward the intersection of Stonewood Street and Walker Ranch where he was flagged down by the original male standing next to the white truck. He told the officer that the red car had turned left onto Village Wood, parked in a driveway and when the officer passed, he made a high speed turn back onto Walker Ranch and then a right hand turn onto West Bitters. The officer turned onto West Bitters, heading eastbound and could see a red in color Dodge Charger at the intersection of West Bitters and West Avenue. As the officer approached the rear of the car he observed the same male who had passed the patrol vehicle in the 500 block of West Bitters, in the reflection of the driver's side mirror. The officer further observed that the male in the red Dodge Charger had the driver's side window down and his left arm out the window. The driver of the car finally came to a stop in the 13600 block of San Pedro. The officer immediately detained the driver, patted him down and placed him in the back seat of the patrol car. He asked the officer what happened and he was informed that he had just evaded the officer back in the neighborhood, to which he replied "I don't know what you're talking about." While standing near the red Dodge Charger the officer could smell the odor of burned brakes, rubber, and transmission fluid. With the officer's 10 years of law enforcement experience, he knew this occurs when a vehicle has been driven at a high rate of speed and stopped quickly. The officer also observed that the suspect's cell phone was lying in the driver's side floorboard, which is seen when a rapid stopping of a vehicle occurs. The suspect was identified by his Texas Driver's License and the computer check came back clear. A second officer went to get a statement from the citizen that had seen the suspect evade the officer. The suspect's vehicle was impounded and the suspect was booked into jail.
