Offense: Suspicious Person

A bank employee reported a male subject had entered the bank and began acting suspiciously when the male began asking questions in regard to the bank's security. The caller said the male had hospital admission bands on his wrist and was presently sitting in the parking lot of the business in a red Acura. Upon arrival to the location, the officer observed a vehicle matching the description provided. As the officer approached the vehicle, he observed a heavy set male in the driver's seat. The officer contacted and identified the male. The male identified himself with a Texas ID card and related his driver's license was expired. The officer informed him of the reason for the contact. Upon talking with him, the officer detected a mental impairment. While speaking with the male, his mother called his cellular telephone and the officer asked to speak with her. The officer informed his mother of the reason for his contact and she did confirm that her son was a diagnosed schizophrenic with a bi-polar disorder. The male also related he had just been released from the hospital the day prior. The mother came to the bank to pick up her son.

An officer was dispatched to assist EMS with a report of an elderly male who was lying face down on the ground. EMS was already on scene when the officer arrived. EMS personnel related they did in fact find him lying on the ground behind the bus stop. EMS had woken him up and had him set on the bus bench. The subject identified himself with a valid driver's license. The male related he was tired and had just fallen asleep at the location. The male was conscious alert and aware of his surroundings. EMS personnel determined the male appeared to be fine. The male refused EMS and related he had relatives that didn't live far away. The male left the location on his own accord. The officer resumed patrol.
