An officer observed compact vehicle speed off at a high rate of speed causing its tires to squeal within the parking lot of Wataburger at 14543 Brook Hollow Blvd. The vehicle continued to accelerate onto San Pedro Ave in a high rate of speed while continuously squealing its tires. Once the violation was observed the officer activated the overhead lights and ordered the driver pull over. The operator of the Mazda came to a complete stop at 15302 San Pedro. Once contact was made with the operator, he stated "I'm sorry that was just stupidity". While obtaining his identification, the front seat passenger said the vehicle belonged to him. When asked for the vehicle's insurance, the passenger reached towards the glove box while stating "I do not have the paperwork and there is a gun in the car". The officer immediately ordered the occupants not to move and seized the firearm for officer safety after the passenger said the weapon was within the glove box. Once the officer had possession of the firearm he asked the passenger if there was anything else he needed to be aware of. The passenger stated "Yes, there's some marijuana in the glove box" Before conducting a vehicle search, the officer asked the passenger if there were any more narcotics in the automobile. The passenger stated "no, all I have is my work equipment and related materials". During the search, one plastic bag of marijuana concealed in a small camo pouch and a pill bottle containing marijuana was located in the vehicle's glove box. Also found during the search was a plastic baggie of a white powdery substance that resemble cocaine and a plastic bag containing 11 blue barbiturates with the number 2531 (later identified as Clonazepam). The officer pulled the suspect item out and asked the passenger if it belonged to him. The passenger said it did belong to him. When the officer asked him what the substance was, he stated "Cocaine". The passenger was arrested and charged for the drugs.
