Offense: Suspicious Vehicle

Date: 07.13.15

Time: 1615 hours

Location: 100 blk Cherokee Lane

An officer received a phone call from an unknown caller in reference to a suspicious vehicle. The caller stated a late model white Ford Mustang has been parking in the 100 block of Cherokee Lane within the past two weeks. The caller stated the Mustang parked from 0800 to 1200 hours for the past couple of days and a couple of days last week. The caller stated the Mustang does not belong to anyone on Cherokee Lane and requested the officer make contact with the driver. The officer responded to the area just in case the Mustang returned. The officer was unable to locate the vehicle. The officer believes the vehicle may belong to a worker at a house under construction on Cherokee Lane.

Offense: Assist other Agency

Location: Shawnee Pass @ E. Borgfeld Road

An officer was dispatched to an Assist Other Agency call in the area of Shawnee Pass and E. Borgfeld Road. The computer notes related that multiple shots were being fired in the area and a deputy was en-route. The officer conducted a patrol of the area with a deputy. Residents in the area provided a description of a truck they believed the shots were coming from. The deputy initiated a traffic stop on a white Ford truck at the intersection of Crazy Horse Drive and E. Borgfeld Road. The male operator had a weapon in the vehicle and was detained by the deputy. It was unable to be determined if the male subject was responsible for firing the shots and there were no apparent signs that his weapon had been recently fired. The HCV officer provided cover for the deputy while a computer check was conducted on the male subject and a check was

completed on the weapon. A search was conducted on the truck and no other weapons were discovered. The HCV officer stayed on scene until no longer needed.

Offense: Violation of State Vehicle Laws

Location: 100 blk South Tower Drive

An officer observed a SUV traveling at a high rate of speed. The stationary radar unit in the patrol car confirmed the vehicle speed was 41 mph in a clearly posted 30 mph zone. The officer conducted a traffic stop on the vehicle. During a computer check, the officer learned that neither the license plate nor registration sticker matched the vehicle. The computer check showed the driver to have a suspended driver's license. The driver told the officer she knew nothing about the sticker or license plates because the SUV belongs to her mother. The officer had the driver call for a ride since she could not drive. The officer seized the license plates and registration sticker. The driver was cited for the violations and released to her ride.

An officer observed a white Ford Explorer Sport Trac pickup truck parked behind an abandoned building located in the 14700 block San Pedro Ave. The vehicle's engine was off and all the windows were down. The vehicle appeared to be unoccupied. The officer then noticed the driver was sleeping in the driver's seat. The driver's seat was completely reclined. The officer woke the male and asked him if he was okay or if he needed any medical attention. The male stated he was on his lunch break and wanted to grab a quick nap before returning to work. The male was wearing a uniform shirt from an electronics store within HCV. The male asked the officer if he could sleep another 10 minutes. The officer said it would be okay. The officer did not see any signs of criminal activity.
