Offense: Possession of a Controlled Substance/Wanted Peron

Date: 09.29.15

Time: 0217 hours

Location: 13800 blk San Pedro

An officer observed a silver Honda Civic travelling in the 15000 block of San Pedro without the tail lamps illuminated. The officer conducted a traffic stop on the vehicle. The officer approached the operator and requested his driver's license. The operator stated that he did not have a license and was driving his passenger's car because he was sick and throwing up. The operator identified himself by name and date of birth. A computer check later revealed that he had four outstanding traffic warrants through the City of San Antonio and he was taken into custody. The driver was sweaty, his eyes were glassy and very nervous, but the officer did not notice an odor of alcohol. The officer suspected that they may have had drugs in the vehicle. The driver and passenger were asked if there were any drugs or drug paraphernalia in the vehicle. The vehicle owner/passenger stated that he "didn't know", and then eventually stated that he had a box of paraphernalia that belonged to him, located on the floorboard of the front passenger seat where he had been sitting. The officer found a box with suspected heroin inside the box. The passenger was asked if he used heroin, which he stated that he did in fact use heroin and that the suspected heroin discovered in the box belonged to him. The driver was arrested for his outstanding warrants and the passenger was arrested for the narcotics. They were Both taken downtown and booked into jail.

Offense: Violation of State Vehicle Laws

Date: 09.30.15

Time: 1439 hours

Location: 100 blk Winding Way

An officer observed a vehicle traveling at a high rate of speed. The speed was confirmed by radar to be 42 mph in a clearly posted 25 mph zone. The officer stopped the vehicle in the 100 block of Tomahawk Trail. The officer informed the driver why he was stopped and requested his license and insurance. The driver stated he was test driving the car and did not have the insurance for the vehicle. The driver also stated he did not bring his license with him on the test drive. The officer obtained his name and date of birth and returned to the patrol car. The officer was able to locate current insurance on the car from the vehicle registration. The computer return revealed two active suspensions for his license. The officer returned to the car and informed the driver that he would not be able to drive from the location due to the suspensions. The officer cited the driver for the violation. The driver contacted a coworker who arrived and transported the customer's car from the location.

Offense: Recovered Stolen Property

Time: 1635 hours

Location: 15700 blk San Pedro

An officer received a phone call from a store manager who reported that several subjects were in his location trying to pawn a stolen iPhone. Upon arrival contact was made with the store manager. The manager reported that the two subjects entered his store earlier in the day and made a pawn transaction on an iPhone6. The manager said that after the subjects left he was able to determine through Apple that the iPhone was stolen. The manager related that the subjects returned to the location trying to pawn two other iPhones. At that time he called police. The female told the officer she had purchased the iPhone 6 several months ago off of Craigslist, from an unknown individual and was not aware that it was stolen. The female showed the officer a text message exchange with the number that came up on the phone's find my iPhone feature. The female was able to provide proof that one of the other iPhones in her possession belonged to her but could not provide proof for the third phone. The officer seized the stolen iPhone and the third phone until proof of ownership could be established. The manager and the female worked out a transaction for the second iPhone and all parties departed the location. This case is under investigation.
